Assisting with schoolwork does not involve solving the problems for the students, but rather helping students to achieve skill and concept mastery in side-by-side learning. Study Hall volunteers are an important part of student support provided in our extended day model.

Seattle Nativity School Confidentiality Agreement

To enable Seattle Nativity School to fulfill its mission, certain confidential and proprietary information will be circulated and exchanged between officers, board members, staff, interns, and volunteers. It is understood and agreed to that Seattle Nativity School may disclose such sensitive information that is and must be kept confidential. To ensure the protection of such information, including confidential information circulated by any other means of sharing information, and to preserve confidentiality, it is agreed that:

1. The Confidential Information to be disclosed by and between Seattle Nativity School, Seattle Nativity School officers, board members, faculty, staff, interns, volunteers, and contract workers can be described as and includes: oral, written or computer generated information not otherwise available to the public at large; computer programs, software and supporting documentation, proprietary ideas and curriculum, technological improvement plans, strategic plans, and financial information; donor data and employee information (including but not limited to co-workers and their families); and any information regarding students and or students' families regardless of whether such information is designated as "Confidential Information" at the time of its disclosure, including such information as students' academic performance, behavior, health, disabilities and related matters.
2. The Recipient shall limit disclosure of Confidential Information within the Seattle Nativity School organization to its executive director, his/her designated staff, officers, attorneys and board members (collectively referred to as "affiliates") having a need to know. The Recipient and affiliates will not disclose the confidential information obtained from the discloser unless required to do so by law.
3. This Agreement imposes no obligation upon Recipient with respect to any Confidential Information (a) that was in Recipient's possession before receipt from Discloser; (b) is or becomes a matter of public knowledge through no fault of Recipient; (c) is rightfully received by Recipient from a third party not owing a duty of confidentiality to the Discloser; (d) is disclosed without a duty of confidentiality to a third party by, or with the authorization of, Discloser; or (e) is independently derived by Recipient.
4. This Agreement states the entire agreement between the parties concerning the disclosure of Confidential Information. Any addition or modification to this Agreement must be made in writing and signed by the parties.
5. If any of the provisions of this Agreement are found to be unenforceable, the remainder shall be enforced as fully as possible and the unenforceable provision(s) shall be deemed modified to the limited extent required to permit enforcement of the Agreement as a whole.

WHEREFORE, the parties acknowledge that they have read and understand this Agreement and voluntarily accept the duties and obligations set forth herein.
